

MES EVENTS TERMS AND CONDITIONS

1. AGREEMENT TO TERMS OF SERVICE

Michigan Esports, LLC ("MES Events") provides its service to you, subject to the following Terms of Service ("TOS"), which may be updated by MES Events from time to time without notice to you. MES Events reserves the right to change LAN event dates or suspend or cancel LAN event, in whole or part, without notice for any reason at any time. Please read this Agreement carefully before purchasing MES Event pass. By accessing or using any part of the website, you agree to become bound by the terms and conditions of this agreement. If you do not agree to all the terms and conditions of this agreement, then you may not purchase an event ticket or use any MES Event services. Users must be 18 years old and above OR 13 years to 18 years old with parental permission. A user between the ages of 13 to 18 certifies that a parent has given permission by checking the box that corresponds, "I certify that I have read and agree to the Terms of Service and the Privacy Policy." The TOS is available for viewing on-line at: <http://MESEvents.com/terms-privacy-policy/> and written copies are available at our events on request. Notice of changes to the TOS or other matters may be made by displaying such notices at our events or by providing such notices to you generally. In addition, when using particular MES Events services, you agree to abide by the MES Events Acceptable Use Statement, the MES Events Server Co-location Agreement and any other guides or rules which may be posted by MES Events from time to time. All such guides and rules are hereby incorporated by reference into the TOS. Where any inconsistency exists between the TOS and any guide or rule, the TOS will prevail. Decisions made by MES Events shall be considered final.

2. DESCRIPTION OF SERVICE

MES Events provides users with access to a local area network ("LAN") of Xbox One or other gaming platforms for the specific purpose of providing an infrastructure by which its users ("the Gamers") can play Xbox One or other gaming platform games against each other either in competition or for pleasure ("the Service"). In addition to the Service, MES Events may allow the Gamers to use Xbox One or other gaming platforms and other network hardware which are provided by MES Events either on its own or in conjunction with other affiliates e.g. its event sponsors ("the Servers") at its events. Unless explicitly stated otherwise, any additional features that augment or enhance the Service, including access to network hardware or software, shall be subject to the TOS. You may, subject to the TOS, connect your own Xbox One or other gaming platform or Xbox One or other gaming platforms to the LAN or accessory devices. You acknowledge and agree that the Service is provided "AS IS" and that MES Events assumes no responsibility for the timeliness of, interruption to, deletion of, misdelivery or failure to facilitate access to the LAN.

3. YOUR REGISTRATION OBLIGATIONS

In consideration of your use of the Service, you agree to provide true, accurate, current and complete information about yourself as prompted by the Service's registration form (such information being the "Registration Data"). If you provide any information that is untrue, inaccurate, not current or incomplete or MES Events has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, MES Events has the right to suspend, terminate or refuse any and all current or future use of the Service (or any portion thereof) by you. You will receive an account designation upon completing the Service's registration process.

4. PRIVACY POLICY

Registration Data and certain other information about you is subject to our Privacy Policy. To request a copy, please contact MES Events. Privacy Policy may be changed by MES Events at any time without notice and the changes will take precedent.

5. YOUR CONDUCT

You are fully responsible for all your activities while using the Service. You agree to notify MES Events immediately of any unauthorized use of the LAN. MES Events cannot and will not be liable for any loss or damage arising from your failure to comply with the provisions contained in this section. You acknowledge that all information, data, text, software, music, sound, photographs, graphics, video, messages and other materials ("Content"), whether publicly posted or privately transmitted, are the sole responsibility of the person from which such Content originated. This means that you, and not MES Events are entirely responsible for all Content that you upload, post, e-mail or otherwise transmit via the Service. MES Events does not control the Content posted via the Service and, as such, does not guarantee the accuracy, integrity or quality of such Content. You acknowledge that by using the Service, you may be exposed to Content that is offensive, indecent or objectionable. Under no circumstances will MES Events be liable in any way for any Content, including, but not limited to, for any errors or omissions in any Content, or for any loss or damage of any kind incurred as a result of the use of any Content posted, e-mail or otherwise transmitted via the Service. Carry out any unlawful act, not otherwise specifically referred to.

6. MANAGEMENT OF CONTENT

You acknowledge that MES Events does not pre-screen Content, but that MES Events and its servants or agents shall have the right (but not the obligation) in their sole discretion to move or delete any Content that is available via the Service. Without limiting the foregoing, MES Events and its servants or agents shall have the right to remove any Content that violates the TOS or is otherwise objectionable. You grant MES Events permission to run manual and/or automatic systems, at its absolute discretion, to determine compliance with and to enforce the TOS and accept that this limited access to and monitoring of your Xbox One or other gaming platform is warranted and lawful. You acknowledge that the technical processing and transmission of the Service, including your Content, may involve transmissions over various networks and changes to conform and adapt to technical requirements of connecting networks or devices. MES Events reserves the right to terminate your access to some or all parts of its Service if you withdraw your consent in this paragraph at any time.

7. INTELLECTUAL PROPERTY RIGHTS OF OTHERS

If you are aware that the intellectual property rights of others or your own intellectual property rights are being or have been infringed on the Service, you agree to immediately provide MES Events with: a description of the copyrighted work that you claim has been infringed; a description of where the material that you claim is infringing is located; your address, telephone number, and e-mail address;

The Service may provide, or third parties may provide, links to Internet sites or resources. Events and govern your use of the Service, superseding any prior agreements between you and MES Events You also may be subject to additional terms and conditions that may apply when you use affiliate services, third-party content or third-party software. The TOS and the relationship between you and MES Events shall be governed by the laws of Michigan. Any disputes shall be decided solely by MES Events. Agreement to TOS waives your right to sue. Any failure by MES Events to exercise or enforce any right or provision of the TOS shall not constitute a waiver of such right or provision. If any provision of the TOS is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavour to give effect to the parties' intentions as reflected in the provision, and the other provisions of the TOS remain in full force and effect. The section titles in the TOS are for convenience only and have no legal or contractual effect.

Please note the MES Points are not the only factor and current and past participation with MES Events, Cinch Gaming and associated entities ,whether Lan or online, will also factor in your team seeding. The final discretion is MES Events and in no way be challenged or argued. Any protesting of seeding may result in your disqualification and removal from MES Events with no refund or liability whatsoever.
